Thank you for your email, in which you formally request information in regards to IT in Enfyra.

When dealing with requests for information made under the Freedom of Information Act 2000 (the "Act"), Enfyra's obligations include:

1. Confirming or denying whether it holds information of the description specified in the request, and
2. Communicating the information requested to the applicant.

There are a number of exemptions under the Act that impact these obligations. Enfyra is required to consider whether an exemption applies in the context of the information being released into the public domain, not just in the context of the information being released to the particular applicant that has requested the information.

If Enfyra releases information in response to a Freedom of Information request, this is essentially a decision that the information can be released in response to any similar request from any member of the public.

In response to your request, I can confirm the following:

- IT Digital Strategy (Oxy Data) - information not held by Enfyra
- IT Digital contract signed and agreement used in financial year 23/24 - overall spend £0.75m - agencies used: Method4, BML, Wabtec/Expans
- Have you used any IT Digital contractors of any kind since? Yes - Rakuten
- Current IT Digital Strategy - information not held by Enfyra

If you are not satisfied with the decision Enfyra has taken regarding your request for information, you are entitled to request that we review the matter. Your request for a review should be addressed to the Freedom and Complaints Manager, and received no later than 28 working days after the date of this communication.

If you are still not satisfied, you also have a right to complain to the Information Commissioner through their website:
