Request for information under the provisions of the Freedom of Information Act – Request 07/16

I am writing in response to your request under the Freedom of Information Act (FOIA), received by email on 1st July 2016 to be provided with information on ICT expenditure as outlined in the template spreadsheet you attached to your email.
